MARINA SLIP WAITING LIST POLICY

In order to lease a slip in DWK Marina a member must first be on the “Marina Slip Waiting List”(herein referred to as “MWL”) for either a 20’,30’,or 40’ slip. In order to be on “MWL” you have to agree and comply with the following conditions:

- #1. Fill out an application for the type of slip you request.
- #2. Applicant must be a member in good standing, and on title to property and boat.
- #3. Applicants application must be accompanied with a deposit for one month rent +10.00 (adm. fee non-refundable) this deposit is based on one twelfth of the annual lease fee for the size of the slip applicant is applying for. Example below:
 - 20’ slip (annual-\$594.) $1/12 = 49.50 + 10. \text{ adm. fee total } 59.50$
 - 30’ slip (annual-\$891.) $1/12 = 74.25 + 10. \text{ adm. fee total } 84.25$
 - 40’ slip (annual-\$1188.) $1/12 = 99.00 + 10. \text{ adm. fee total } 109.00$
- #4. If member is already on a list the same deposit and fee apply but member retains his position on that list. All new applicants go to the bottom of the list.
- #5. If member withdraws before a slip becomes available his deposit will be refunded minus the 10.00 adm. fee. If a member is offered a slip and refuses, his deposit is not refundable, and is removed from the list.
- #6. In order to renew position on MWL after first of every year a 10.00 adm. fee is required.
- #7. Information (copies of lease and marina rules) will be provided to applicant with application.
- #8. Applicants deposit is due at time of acceptance and will be applied to first years lease.
- #9. Position on MWL is not transferable to any other person.
- #10. It should be clear that we will notify member one (1) time by certified letter when a slip is available and that it is members responsibility to promptly contact the office. Failure to respond will cause forfeiture of deposit. Response time for being notified is (5 business days from receipt of certified letter). It is the responsibility of the member to keep contact information current in order for the office to notify availability of slips.
